Present during the meeting were Commissioners Aberasturi, Merrick and Hoagland, Clerk Barkell, Deputy Clerk Russell, Natural Resources Director Jim Desmond, Treasurer Richards, Assessor Endicott, Sheriff Grant, Owyhee County resident Pat Reindel and Sean Chaney with the Owyhee Avalanche.

In departmental issues, Sheriff Grant brought up the issue of not enough ATV road signs on Reynolds Creek Road, the board agreed and Sheriff Grant will be ordering more signs for this road and various others.

In public comment, resident Pat Reindel met with the Board to discuss his concern regarding CUP's and junkyards, mobile homes, etc. being placed on private property, as well as nuisance junk on private property.

Commissioner Hoagland made a motion to approve Resolution 2017-14; Authorizing transfer of excess sale proceeds to that state treasurer pursuant to Idaho Code § 31-808. Seconded by Commissioner Merrick. Commissioner Merrick – aye, Commissioner Hoagland – aye, Commissioner Aberasturi – aye, motion carried.

Commissioner Merrick made a motion to approve the Emergency Medical Dispatching Contract with Sawtooth Correctional Medicine. Seconded by Commissioner Hoagland. Motion carried.


Commissioner Merrick made a motion to approve Indigent and Charity case 17-13. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Merrick made a motion to deny Indigent and Charity case 17-19. Seconded by Commissioner Hoagland. Motion carried.
