Commissioner Hoagland made a motion to adopt Resolution 2018-11: To adopt the Murphy Airport Layout Plan authorized by GDA Engineering, as an Owyhee County Plan for Incorporation into the Owyhee County Code. Seconded by Commissioner Merrick. Motion carried.

Commissioner Hoagland made a motion to approve the Sheriff's new hire for patrol deputy of Jessica Will to begin April 9, 2018 at \$15.94 per hour. Seconded by Commissioner Merrick. Motion carried.

Departmental Quarterly Reports were presented to the Board.

At 11:00 Indigent and Charity hearing for case 18-02 was held. Present were Commissioners Aberasturi, Hoagland and Merrick, Hearing Officer Desmond, Indigent and Charity Clerk Evans, Clerk Barkell, Deputy Clerk Russell. An attorney for West Valley Medical Center was present before the hearing but did not appear at the hearing as the applicant was not present as he assumed would be. Deputy Evans was sworn in and recommended to the Board to amend the February 5, 2018 decision and approve case 18-02. Commissioner Merrick made a motion to approve case 18-02. Seconded by Commissioner Hoagland. Motion carried. The hearing was concluded at 11:10 a.m.


At 11:15 Indigent and Charity hearing for case 18-01 was held. Present were Commissioners Aberasturi, Hoagland and Merrick, Hearing Officer Desmond, Indigent and Charity Clerk Evans, Clerk Barkell, Deputy Clerk Russell. No others were present. Deputy Evans was sworn in and submitted Exhibit 1 (Application), Exhibit 2 (Medical) and Exhibit 3 (Correspondence) and recommended to the Board to affirm the February 20, 2018 decision to deny and accept the withdrawal from the provider. Commissioner Merrick made a motion to affirm the February 20, 2018 to deny and accept the withdrawal of case 18-01. Seconded by Commissioner Hoagland. Motion carried. Hearing Officer Desmond made a comment that in the hearing for Indigent and Charity case 18-02 he inadvertently did not admit Exhibit 1 (Application), Exhibit 2 (Medical) and Exhibit 3 (Correspondence). The hearing was concluded at 11:10 a.m.
