Present were Commissioner's Jerry Hoagland, Richard Freund and George Hyer, Deputy Clerk Trina Aman, Prosecuting Attorney, Douglas Emery, Deputy Prosecuting Attorney, Chuck Saari, Sheriff Daryl Crandall, Planning and Zoning Administrator, Mary Huff, Jim Desmond.

Commissioner Hoagland called the meeting to Order. Commissioner Freund made a motion to amend the agenda to add the December 14, 2009 minutes, ratify signing of Power Grant. and to approve the agenda as amended. Commissioner Hyer seconded the motion. Freund-aye, Hyeraye, Hoagland-aye.

Commissioner Freund recommended that the starting time for setting the agenda be set at 9:31 a.m. instead of 9:55 a.m. Commissioner Hoagland agreed.

The Commissioner's initialed the hand written correction that was made on page #3 of the agreement. No further discussion. Commissioner Hyer moved to approve the agreement as amended. Commissioner Freund made a motion to approve the Memorandum to Facilitate Co-Ordination between Owyhee County and Owyhee Initiative Inc. Commissioner Hyer seconded the Motion. Freund-aye, Hyer-aye, Hoagland-aye.

Ratify signatures for the Power Grant Application. Commissioner Freund made a motion for signatures. Commissioner Hyer seconded the motion. Freund-aye, Hyer-abstained, Hoaglandaye.

Commissioner Freund made a motion to move into Indigent and Charity. Commissioner Hyer seconded the motion. Freund-aye, Hyer-aye, Hoagland-aye.

Deputy Belle Evans presented Indigent and Charity, case 09-51, 09-52, 09-53, 09-54. Commissioner Freund made a motion to approve the liens on case 09-51, 09-52, 09-53, 09-54. Commissioner Hyer, seconded the motion. Freund-aye, Hyer-aye, Hoagland-aye. On case no. 09-45, 09-47, 09-53, Commissioner Freund made a motion to approve agreement.
