APRIL 1, 2013

Present were Commissioner's Joe Merrick, Jerry Hoagland, and Kelly Aberasturi, Deputy Clerk Trina Aman, Assessor Brett Endicott, Sheriff Perry Grant, Planning & Zoning Administrator Mary Huff, and Deputy Clerk Kristal Clausen.

Commissioner Merrick called the meeting to order. Commissioner Hoagland made a motion to amend the agenda to include the Modification of Contract with Mountain Home Air Force Base on Road Maintenance. Commissioner Aberasturi seconded the motion. Motion carried.

Commissioner Hoagland made a motion to set the agenda as amended, seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to sign the Modification of Contract with Mountain Home Air Force Base for maintenance of the road by Road District 3 in the amount of \$33,695.67. Commissioner Aberasturi seconded the motion. Motion was unanimous.

Commissioner Hoagland made a motion to approve the Board Minutes for the March 25<sup>th</sup> meeting. Commissioner Aberasturi seconded the motion. Motion was unanimous.

Commissioner Hoagland made a motion to amend the agenda to include a letter to Mr. Mendenhall regarding 2011 property assessment. Commissioner Aberasturi seconded the motion. Motion carried.

Commissioner Hoagland made a motion to send a letter to Mr. Dale Mendenhall denying his request for a \$1,000 credit on his 2011 property taxes, as his appeal was not presented in a timely manner. Commissioner Aberasturi seconded the motion. Motion was unanimous.
