At 9:00 A.M. Commissioner Merrick called the meeting to order.

Commissioner Hoagland made a motion, seconded by Commissioner Aberasturi to set the Agenda. Motion carried.

Commissioner Hoagland made a motion to approve the June 17th, 2013 Board minutes. Second by Commissioner Aberasturi. Motion carried.

Sheriff Grant presented a pay authorization to hire new jailer, James Vail to replace departing jailer Zeb Baney, at \$14.35 per hour. Commissioner Aberasturi made a motion to approve. Second by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to amend the Agenda to include a pay authorization moving David Bowers from part time to full time for Road District 1. Second by Commissioner Aberasturi. Motion carried. Commissioner Hoagland than moved to approve the pay authorization at \$14.35 per hour. Second by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve the service proposal from Intermountain Communications for programming of repeater stations in the amount of \$2667.00. Second by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to execute the Idaho Community Development Block Grant Program Sub-recipient Agreement for the Bruneau American legion Post #83. Second by Commissioner Aberasturi. Motion carried.

Jim Desmond presented the final draft for the Owyhee County Comment on Final Environmental Impact Statement for the Gateway West Transmission Line. Further input was taken from Karen Steenhof representing the Sage Grouse Local Working Group. Commissioner Hoagland made a motion to approve and send the comments. Second by Commissioner Aberasturi. Commissioner Hoagland made a motion to recess as Board of County Commissioners and convene as Owyhee County Board of Equalization. Second by Commissioner Aberasturi. Motion carried.

There being no matters before the Board of Equalization at this time, Commissioner Hoagland made a motion to recess the Board of Equalization until July 1, 2013 at 1:30 p.m. Second by Commissioner Aberasturi. Motion carried.
