Appeal No. 10-02 Dennis Fulk did not appear to be heard on Parcel No. LR005600020014A. After hearing the testimony given by Assessor Endicott Commissioner Freund made a motion to uphold the Assessors valuation. Commissioner Hoagland seconded the motion. Hoagland-aye, Freund-aye.

Appeal No. 10-03 Joseph and Maria Richards did not appear to be heard on the appeal of valuation on Parcel No LR005600020122A. Assessor Endicott gave testimony. After consideration of the testimony Commissioner Freund made a motion to uphold the Assessor's valuation. Commissioner Hoagland seconded the motion. Hoagland-aye, Freund-aye
