Commissioner Hoagland made a motion to approve a grant application and supporting letters of intent to the Bureau of Homeland Security in the amount of \$10,417.00. Seconded by Commissioner Aberasturi. Motion carried.

Murphy Flat Road residents Ann Baker, Craig Baker and Ed Olsen, and Road and Bridge District #1 Supervisor Phil Rittenhouse met with the Board to discuss the condition of Murphy Flat Road. Ann Baker submitted several photos of the road showing water over the road from irrigation run-off, pot holes and the lack of barrow-ditches. She also stated that several residents' mailboxes along the road have had to be moved because the Post Office refuses to drive that part of the road. She voiced concern of emergency vehicles and/or individuals unaware of the condition of the road traveling at a higher than usual rate of speed along that stretch and wrecking because of the condition of the road. Phil Rittenhouse and the Commissioners stated their plans to re-build the road are in the near future, but for time being they are going to work with the Sheriff to help with the irrigation run-off and possible violations and then start making temporary repairs to the road until they can start re-building the road.

Commissioner Hoagland made a motion to approve an application for a Right of Way for boat trailer parking at Black Sands. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to go into executive session pursuant to Idaho Code 67-2345(1) (f) for possible litigation. Commissioner Aberasturi seconded the motion. Aberasturi – aye, Hoagland – aye, Merrick – aye. Motion was unanimous. No action was taken.

Commissioner Hoagland made a motion to go out of executive session. Commissioner Aberasturi seconded the motion. Motion carried.
