A budget hearing was held on the proposed 2011 Owyhee County budget. Elected Officials and Department Heads were present to answer questions on their budgets.

Discussion was held on Planning and Zoning violations in Silver City. A letter was received from Mr. & Mrs. Fiske in regards to Lot 45 and reviewed by the Board. A letter was received from Peter Burril and John Wilper concerning a fence on lot 59. A letter was received from Dan Heuck regarding a skylight violation, and an inspection report was received from McClendon Engineering on the Undertakers Parlor. Commissioner Freund asked Mary Huff to forward the letter from Mr. Heuck to the Historic Preservation Commission.

Commissioner Freund made a motion to amend the agenda to include adoption of the 2011 Owyhee County budget. Commissioner Hyer seconded the motion. Hyer-aye, Freund-aye, Hoagland-aye.

Commissioner Hyer made a motion to adopt Resolution 2010-26, Adopting the Fiscal Year 2011 Owyhee County Budget in the amount of \$7,335,224. Commissioner Freund seconded the motion. Hyer-aye, Freund-nay, Hoagland-aye.

Deputy Evans presented Indigent & Charity case no. 10-32. Commissioner Freund made a motion to approve the applicant. Commissioner Hoagland seconded the motion. Freund-aye, Hoagland-aye.
