At 9:00 A.M. Commissioner Merrick called the meeting to order.

Citizen Robert Cooley updated the Board on his endeavor to persuade the Department of Environmental Quality to take action on the nuisance property located next to his property. He reported that the local department was forwarding his request on to the State DEQ.

Old Business – Scot Jensen, County Extension Agent, forwarded to the Board documents on the Energy Grant from Idaho Power to replace lighting the lighting at the Extension Building. Commissioner Aberasturi made a motion to approve the project with H&H Electric in the amount of \$2485.83 with \$1006.00 being reimbursed from Idaho Power when the project is completed. Second by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to decline the additional offer of terrorism coverage from ICRMP. Second by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to waive building permit fees in the amount of \$306.90 for the construction of a lean-to for the Sheriff at the old County Shop site off of Delmar Road. Second by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to move into closed session for Indigent and Charity Matters. Second by Commissioner Aberasturi. Motion carried.

Indigent Director Evans presented the following cases for review:
