Commissioner Hoagland made a motion to approve the minutes from the January 12, 2015 Commissioner meeting. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve the appointment of Rachel Criffield as Fair Board Member and to accept the resignation of Dennis Dines. Motion seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve 4 Certificates of Residency to the College of Western Idaho for Carley Bond, Jaclyn Glansman, Orrie Lowry and Maria Martinez. Seconded by Commissioner Hoagland. Motion carried.

Jordan Zwygart with Zwygart & Associates PC Public Accountants presented the Board with the 2014 Annual Audit Report. Mr. Zwygart reported there were no issues or discrepancies in the audit, and felt no changes need to be made to the accounting practices. All funds, budgets, grants and spending looked good for the year. Commissioner Aberasturi made a motion to approve the 2014 Annual Audit Report. Motion was seconded by Commissioner Hoagland. Motion carried.

Rita Dixon with Idaho Department of Fish and Game met with the Board to explain the Wildlife Action Plan that the county has been asked to participate in reviewing and renewing. This Plan is updated every 10 years, various stakeholders, government agencies and groups have been asked to be involved. The Plan identifies and is focused on the "species in greatest need of conservation" with a criteria of 8 areas that must be met to identify and address each species and their related issues. Natural Resources Director Jim Desmond is tentatively planning on attending the statewide meeting to discuss the Plan in Late January.

Adam Rothenbuhler, John Yancey and Jim Merritt representing Corporate Technologies LLC, met with the Board to discuss recent technology issues regarding the courthouse and Sheriff Department computer systems and programs. In order to try and resolve some of the recent issues with the call center, Boise General Manager Jim Merritt will now be contacted in the event there is an issue that needs resolved. The Board scheduled Corporate Technologies for the February 23, 2015 Commissioner meeting to evaluate the progress within that month.

A coordination meeting was held with the Boise District BLM Office.

Commissioner Hoagland made a motion to go into executive session pursuant to Idaho Code 67-2345(1)(a) for personnel issues. Commissioner Aberasturi seconded the motion. Aberasturi – aye, Hoagland – aye, Merrick – aye. Motion was unanimous. No action was taken.
