Commissioner Aberasturi made a motion to approve the minutes from the February 17, 2015 meeting. Seconded by Commissioner Hoagland. Motion carried.

Assessor Endicott presented to the Board building footage and valuations for county buildings to evaluate proper insured values.

The Computer Arts Contract Addendum was tabled until the March 2, 2015 meeting.

Commissioner Hoagland made a motion to approve the temporary part time hire of Margaret Ethington to the Prosecuting Attorney's office in the amount of \$10.00 per hour. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve the temporary part time hire of Jay Cowger to the Prosecuting Attorney's office in the amount of \$9.25 per hour. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve a Certificate of Residency to the College of Southern Idaho for Laila Golrangi. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve a Certificate of Residency to the College of Western Idaho for Melinda Carter. Seconded by Commissioner Hoagland. Motion carried.

Corporate Technologies Inc. (CTI) met with the Board to discuss and evaluate the recent issues regarding computer problems in the Sheriff Office as well as the Courthouse. The decision was made for the Sheriff Office to terminate their contract with CTI and for the Courthouse to continue their work relationship with CTI. The current contract regarding hours and amounts will be discussed to adjust for the discontinuance of the Sheriff Office portion.
