## OWYHEE COUNTY COMMISSIONERS MINUTES August 17, 2015 OWYHEE COUNTY COURTHOUSE MURPHY, IDAHO

Present were Commissioners Merrick, Hoagland and Aberasturi, Clerk Barkell, Deputy Clerk Russell, Assessor Endicott, Sheriff Grant, Chief Deputy Bowman, Natural Resources Director Desmond, Indigent and Charity Director Evans, Mike Kaes representing Paragon Consulting, Dale Nalder with Bureau of Homeland Security, Wes Anderson representing Murphy Reynolds Wilson Fire Department, Pechota's Type 1 Team representatives David Boyd, Karl Stocker and Dana Schmidt and Sean Chaney with the Owyhee Avalanche.

The National Interagency Fire Center's Pechota's Type 1 Team representatives Boyd, Stocker and Schmidt briefed the Board on the latest information and statistics of the Soda Fire. Current total loss of acreage is estimated at 283,000, 80% BLM owned property, 15% private property, 5% State land and a sliver of Department of Reclamation owned land. Cost so far is at \$4.7 million with 811 persons assigned to the fire. Mr. Stocker said they are optimistic for 100% containment in the upcoming days if the weather continues to cooperate.

Mike Kaes with Paragon Consulting presented to the Board the importance of preventative maintenance to the landscape prior to heavy rains on the recently burned land. Loss of roads, culverts, etc. can happen due to washouts and flooding as the burned soil acts as 'pavement' and heavy run-off can cause major damage to the roads. He suggested contacting the Bureau of Land Management and the Natural Resource Conservation Service for possible financial assistance of the maintenance.

Commissioner Hoagland made a motion to approve the partial payment to Seubert Excavation in the amount of \$212,039.28. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve the Interpretive Services Agreement between Owyhee County and Grace Arroyo for fiscal year 2016. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve the Inmate Telecommunications Location Agreement between Owyhee County Jail and TelMate. Seconded by Commissioner Hoagland. Motion carried.
