At 9:45 a.m. Donna Bennett with Grand View Ambulance Service met with the Board to request the purchase of equipment to better serve the volunteers lifting and transporting. Commissioner Hoagland made a motion to approve the purchase from Haz-Mat funds of an automatic gurney in the amount of \$17,009.41 and a power lift loader in the amount of \$16,589.65 for a total of \$39,104.76. Seconded by Commissioner Merrick. Motion carried.

At 10:00 a.m. Southwest Idaho Juvenile Detention Center Director Steve Jett and Owyhee County Probation Director Ivy Cardenas met with the Board for the annual report. Mr. Jett was pleased to announce the rate will not increase for this year and will remain \$160 per day. He reported that their school program (Kahn Academy) is second to none and has increased the level of knowledge in the students school courses. Out of 100 schools (detention level) this program is 11th with 5 of the top 11 students as well. He described the numerous programs set in place such as fixing donated bikes and engines, as well as a week of equine schooling. He explained the intent of their programs are to better the kids so they are not returning. The majority (61%) do not return.

Commissioner Hoagland made a motion to approve a press release regarding the Gateway West transmission line exemptions. Seconded by Commissioner Merrick. Motion carried.
