Commissioner Merrick made a motion to approve the application with no comments for the Bruneau Water and Sewer District Application for USDA Federal Assistance for the upgrades to the existing sewage system. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve the Sheriff's new hire of Caitlin Day as dispatcher in the amount of \$14.76 per hour to begin on August 15, 2017. Seconded by Commissioner Merrick. Motion carried.

Commissioner Hoagland made a motion to approve 6 Certificates of Residency to the College of Western Idaho for students 2017-120 to 2017-125. Seconded by Commissioner Merrick. Motion carried.

Commissioner Merrick made a motion to place a lien on Indigent and Charity cases 17-38 and 17-39. Seconded by Commissioner Hoagland. Motion carried.
