OWYHEE COUNTY COMMISSIONERS MINUTES February 5, 2018 OWYHEE COUNTY COURTHOUSE, MURPHY OWYHEE COUNTY, IDAHO

At 8:44 a.m. Commissioner Hoagland made a motion to go into executive session pursuant to Idaho Code 74-206(d) records exempt from public disclosure. Commissioner Merrick seconded the motion. Merrick – aye, Aberasturi – aye, Hoagland - aye. Motion was unanimous. No action was taken.

The attorney legal staffing portion of the meeting was held at 8:49 a.m.

At 9:10 a.m. Stephanie Garner with Pioneer Title and realtor Randy Reinertson met with the Board. Commissioner Hoagland made a motion to approve the purchase of parcel RPC0740005001AA in the amount of \$14,083.54 (the former Murphy Post Office property) and authorize Chairman Aberasturi to sign the closing documents on the Boards behalf. Commissioner Merrick made a motion to approve Resolution 2018-5; Cancellation and Adjustment of erroneous tax assessment for Mountain View Equipment Company. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve Resolution 2018-6; Destruction of temporary Indigent and Charity records. Seconded by Commissioner Merrick. Motion carried.

Commissioner Hoagland made a motion to designate the polling places for the March 13, 2018 Election; Glenns Ferry School District levy, as approved by the Secretary of State is a mail ballot precinct. Castleford School District levy, as approved by the Secretary of State is a mail ballot precinct. Both locations are the Owyhee County Courthouse, 20381 State Hwy 78, Murphy, Idaho. Seconded by Commissioner Merrick. Motion carried.

The Idaho Department of Lands, State of Idaho Mineral Leases and Bond Assurance was tabled for clarification.

Commissioner Hoagland made a motion to approve a catering permit for the Pour House and Owyhee Cattlemen's Association to be held on February 10, 2018 from 5:00 p.m. until 9:00 p.m. at the Oreana Community Hall. Seconded by Commissioner Merrick. Motion carried.

Commissioner Merrick made a motion to amend the determination of approval for Indigent and Charity case 17-57 to add a service date. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Merrick made a motion to approve Indigent and Charity case 17-62. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Merrick made a motion to approve Indigent and Charity case 17-65. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Merrick made a motion to deny Indigent and Charity case 18-02. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Merrick made a motion to deny Indigent and Charity case 17-50 as the applicant was approved by Medicaid. Seconded by Commissioner Hoagland. Motion carried.

Tina Wilson with Western Alliance / Economic Development, Fair Manager Ginger Loucks, and Kirby Cook with Civil Dynamics met with the Board to review the grant budget format for the Idaho Department of Commerce, Idaho Community Block Development Grant application for the new community building at the fairgrounds. No action was taken.

At 10:30 a.m. Commissioner Hoagland made a motion to go into executive session pursuant to Idaho Code 74-206(a) employee matters. Commissioner Merrick seconded the motion. Merrick – aye, Aberasturi – aye, Hoagland - aye. Motion was unanimous. No action was taken.

At 11:00 Brianne McCoy with the Public Defense Commission met with the Board for a brief overview of happenings; current standards in place include vertical representation, private meeting space, attorney present at first appearance and all defense attorneys must have 7 units of indigent training per year. They would like to see the following passed: Capital Defense Standard (which attorney is best qualified for a capital defense), ability to have enforcement, the use of investigators and a workload standard. Annual grant applications are available February 28, 2018 and are due May 1, 2018.

At 11:30 a.m. Treasurer Dygert held a telephone conference with Lynda Zamudio regarding a tax hardship for a relative. After explanation and understanding of the situation, Commissioner Hoagland made a motion to grant a tax hardship for parcel RPA00100480120A, taxes in the amount of \$343.08 and a solid waste amount of \$27.50. Seconded by Commissioner Merrick. Motion carried.

Commissioner Hoagland made a motion to approve a letter to Ernest Breuer and Robyn Thompson regarding the Administrative Order 2008-5. Seconded by Commissioner Merrick. Motion carried.

After reviewing the Owyhee County Funding Support Application's received from 5 of the first responders, Commissioner Merrick made a motion to approve the applications for Homedale Police Department, Marsing Ambulance, and the Bruneau Fire District (less contributing match amounts). Seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve Resolution 2018-6; To sell surplus vehicles and miscellaneous items with JBS Auctions online, with bidding to begin March 5, 2018. Seconded by Commissioner Merrick. Motion carried.

Commissioner Merrick made a motion to pay the Capital Crimes Defense bills through the Indigent and Charity fund in the amount of \$14,088.76. Seconded by Commissioner Hoagland. Motion carried.

There being no further business the meeting was adjourned.
