Commissioner Merrick made a motion to set the agenda as presented. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to set the Homedale re-zoning meeting to be held on Wednesday May 9, 2018 at 6:00 p.m. at the Homedale City Hall courtroom. Seconded by Commissioner Merrick. Motion carried.

Commissioner Hoagland made a motion to approve the pay increase for Chief Deputy Treasurer Tami McGrew from \$16.74 per hour to \$17.75 per hour, to begin April 1, 2018. Seconded by Commissioner Merrick. Motion carried.

Commissioner Hoagland made a motion to approve (2) certificates of residency to the College of Western Idaho for students 2018-119 and 2018-120. Seconded by Commissioner Merrick. Motion carried.

Commissioner Hoagland made a motion to approve (1) certificate of residency to the College of Southern Idaho for student 2018-22. Seconded by Commissioner Merrick. Motion carried.

At 9:30 a.m. Rick Patton with GDA Engineers met with the Board to discuss the Murphy Airport Layout Plan. Commissioner Merrick made a motion to approve the plan and authorize Commissioner Aberasturi to sign the plan on the Boards behalf. Seconded by Commissioner Hoagland. Motion carried.


At 10:00 a.m. Steve Jett with Southwest Idaho Juvenile Detention Center and Owyhee County Juvenile Probation Supervisor Ivy Cardenas met with the Board to discuss the FY19 budget, with an increase from \$160 to \$170 per day for out of county housing.

Commissioner Merrick made a motion to approve a letter to Lance Okeson with Boise District BLM Office regarding a request for SODA Fire monitoring and assessment data. Seconded by Commissioner Hoagland. Motion carried.

At 1:00 p.m. the annual State Insurance Fund supervisor's safety training was held.
