During the public comment period, Oreana resident Terry Jenson met with the Board to discuss an issue occurring on her property involving possible code violations. She asked that the Board issue a warning letter that she will make sure the 'other party' receives.

Commissioner Hoagland made a motion to approve an annual maintenance agreement with McLaughlin's Owyhee Heating and Air Conditioning for the spring and fall startups in the amount of \$1,685.00 per season. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to authorize Chairman Aberasturi to sign the above-mentioned document on the Boards behalf. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve the Treasurers tax cancellation on parcel MH03N06W267650, taxes in the amount of \$65.66 / solid waste fee of \$27.50 / penalty of \$1.31. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve (6) certificates of residency to the College of Western Idaho for students 2018-172 through 2018-177. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve (3) certificates of residency to the College of Southern Idaho for students 2018-26 through 2018-28. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to place a lien on Indigent and Charity case 18-29 and 18-30. Seconded by Commissioner Aberasturi. Motion carried.

At 10:00 a.m. the Homedale Rezoning Ordinance Amendment public meeting was held. No public or interested parties were in attendance. Planning and Zoning Director Huff explained changes to the Board. There being no opposition to the changes, Commissioner Hoagland made a motion to approve the amendments to the Homedale Rezoning Ordinance. Seconded by Commissioner Aberasturi. Motion carried.


At 10:30 a.m. the hearing to open the 2018 budget was held. No public or interested parties were in attendance. Commissioner Hoagland made a motion to approve Resolution 2018-22; To open the 2018 budget for Indigent and Charity in the amount of \$515,000.00 and Jr. College Tuition in the amount of \$10,000.00. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve Resolution 2018-23; Ratification of approval by the Owyhee County Commissioners for the Chairman of the Board of County Commissioners to sign and submit Owyhee County Protest of BLM EA and proposed decisions for the Battle Creek, East Castle Creek, and Owens Grazing Allotments. Seconded by Commissioner Aberasturi. Motion carried.
