Commissioner Merrick made a motion to approve the Idaho Oregon River Water Trail membership as Commissioner Hoagland as representative. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve the System for Award Management Entity Registration naming Angela Barkell as Entity Administrator. Seconded by Commissioner Merrick. Motion carried.

Commissioner Merrick made a motion to approve the 2019 Levy Certifications. Seconded by Commissioner Hoagland. Motion carried.

At 9:35 a.m. Juvenile Probation Supervisor Cardenas and Idaho Department of Juvenile Corrections employee Colleen Foster met with the Board to discuss a potential support services coordinator for Juvenile Probation. Commissioner Hoagland made a motion to approve the Contract with Colleen Foster as Independent Contractor for Support Services Coordinator for Owyhee County Juvenile Probation Department. Seconded by Commissioner Merrick. Motion carried.

At 9:45 a.m. Merin Ericson with Hamilton, Michaelson and Hilty Law Office met with the Board to discuss a possible civil attorney contract to replace the former civil attorney with the county. No action was taken.

Commissioner Merrick made a motion to deny Indigent and Charity case 18-28. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Merrick made a motion to withdraw Indigent and Charity case 18-31. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve the Personal Services Contract with Jim Desmond for fiscal year 2019. Seconded by Commissioner Merrick. Motion carried.

Commissioner Hoagland made a motion to approve the 2018 Office of Emergency Management Subrecipient Agreement in the amount of \$27,412.00, with the county matching half, along with

approval of Chairman Aberasturi signing the document on the Boards behalf. Seconded by Commissioner Merrick. Motion carried.


At 1:30 p.m., the Boise BLM District coordination meeting was held.
