Commissioner Hoagland made a motion to go into executive session pursuant to Idaho Code 74-206(f) possible litigation. Commissioner Merrick seconded the motion. Merrick – aye, Hoagland - aye. Motion was unanimous. No action was taken.

Commissioner Hoagland made a motion to approve the comment to USDA/APHIS regarding the Mormon cricket control scoping document. Seconded by Commissioner Merrick. Motion carried.


