At 10:00 a.m. the Board held a discussion regarding the Murphy water system. Road and Bridge #1 Supervisor Rittenhouse and Murphy resident Ross Gruenwald were in attendance. The pipes are in need of replacing as they are deteriorating and leaking on a regular basis. As further quotes come in for the project, Supervisor Rittenhouse may begin to replace/repair a small portion of the pipes. Eventually, with grant funding, the entire water system will need to be replaced.

At 11:00 a.m. Owyhee Soil and Water Conservation District representatives Debbie Abel, Andrea McRae and Charles Kiester met with the Board to request the Districts annual funding. Due to possible, unforeseen expenses, the District is requesting \$4,500.00 for FY19, rather than the \$3,000.00 they have requested in recent years. The Board will discuss in the upcoming months and respond.

At 1:30 p.m. the Boise District BLM Coordination meeting was held.

Commissioner Merrick made a motion to approve the Murphy Flat Road Right of Way Grant from BLM, and to authorize Chairman Hoagland to sign on the Boards' behalf. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Merrick made a motion to amend the agenda, due to time restraints, to include a letter to Bonner County regarding the transfer of the Sheriff's Pinzgauer vehicle. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Merrick made a motion to approve a letter to Bonner County Commissioners regarding the transfer of the Pinzgauer vehicle the Owyhee County Sheriff Department has possession of. Seconded by Commissioner Aberasturi. Motion carried.
