Commissioner Aberasturi made a motion to appoint Doug Rutan of South Mountain to the Owyhee County Fair Board. Seconded by Commissioner Merrick. Motion carried.

Commissioner Aberasturi made a motion to approve the quote for bleachers for the Owyhee-County Fairgrounds in the amount of \$47,805.00. Seconded by Commissioner Merrick. Motion carried.

Commissioner Aberasturi made a motion to approve the termination of TelMate Inmate Phone Services. Seconded by Commissioner Merrick. Motion carried.

He also asked if the Board would purchase cameras to be placed at Grand View and Bruneau collection sites to help identify those who are in violation of dumping garbage that is not allowed. Grand View City will possibly be converting to mandatory garbage pickup within city limits which should help eliminate excess garbage at the Grand View site.
