May 28, 2019

Present during the meeting were Commissioners Aberasturi, Merrick and Hoagland, Clerk Barkell, Deputy Clerk Russell, Treasurer Dygert, Chief Deputy Assessor Hinton, Chief Deputy Sheriff Bowman, Mr. and Mrs. Steve Jett and Chelsea Schwickert with Southwest Idaho Juvenile Detention Center.

Commissioner Aberasturi made a motion to approve a catering permit for The Spot Pizza Place LLC from June 1st to 2nd, 2019 from 10:00 a.m. to 10:00 p.m. at the Owyhee County Historical Society and Museum for Outpost Days. Seconded by Commissioner Merrick. Motion carried.

Commissioner Merrick made a motion to set the agenda as presented. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Merrick made a motion to approve the minutes from the May 17th and May 20th meetings. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve the Treasurers tax cancellation for parcel RP15S11E320040, Three Creek Highway District, with a penalty of \$3.97 and solid waste fee of \$114.00. Seconded by Commissioner Merrick. Motion carried.

Commissioner Merrick made a motion to approve the Nettleton Gravel Pit Lease for sheriff training, in the amount of \$500 per year. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve (7) 2020 Retail Liquor Licenses - #21 Café Leku dba Moxie Java Bistro/Tango Saloon/Arena, #22 Salvador Salinas dba Salinas Raider Express Café, #23 Snowbirds LTD dba Pour House, #24 Grazing H, LLC dba Idaho Pizza Company, #25 Trans-Denco LLC dba Last Chance Saloon, #26 Robert Lemieux dba Jumbo's Auto Supply and #27 Fisher's Saloon, LLC dba Fisher's Saloon. Motion seconded by Commissioner Merrick. Motion carried.

Commissioner Aberasturi made a motion to approve pay application #4 to Succor Creek Construction for the Homedale Community Center in the amount of \$170,595.17. Seconded by Commissioner Merrick. Motion carried.


Commissioner Merrick made a motion to place a lien on Indigent and Charity case 19-35. Seconded by Commissioner Aberasturi. Motion carried.

Southwest Idaho Juvenile Detention Center administrator Steve Jett and clinician Chelsea Schwickert met with the Board to update them on the full time hiring (previously contracted) of Chelsea, along with part time on call clinicians who will evaluate each juvenile when first brought in. This position is funded through the State of Idaho. The current daily rate is \$170 and fiscal year 2020 that will increase to \$191 per day, starting October 2019.
