Commissioner Merrick made a motion to change the June 24, 2019 decision for Indigent and Charity case 19-38. Seconded by Commissioner Aberasturi. Motion carried.

At 10:00 a.m. the 2020 budget hearing was held. No interested public was present. Commissioner Aberasturi made a motion to approve Resolution 201-16: Fixing the Owyhee County budget for fiscal year 2020 in the amount of \$11,505,064.12. Seconded by Commissioner Merrick. Motion carried.

At 10:30 a.m. University of Idaho Extension Office Educator met with the Board to discuss that the upcoming Extension Agreement will be a statewide form that applies to each county. The contract was forwarded to the Prosecuting Attorney for review and will be approved at a later date once the Prosecutor approves.

At 11:30 a.m. Commissioner made a motion to recess as the Board of County Commissioners and convened as the Marsing Ambulance District Board. Motion was seconded by Commissioner Aberasturi. Motion carried.


