The Modification exercising option year two for the Owyhee Road Maintenance contract for Mountain Home Air Force Base was tabled.

Planning and Zoning Director Huff presented to the Board the findings from the Marsing to Sinker Creek Rezoning public hearing. The Board decided to proceed with changes discussed at the hearing held on February 11, 2020 and will schedule the matter for an upcoming meeting for final consideration and adoption.

Daniel Kangas and Carl Bader met with the Board to discuss possible Murphy Townsite water hook-ups for 6 lots Mr. Kangas is interested in purchasing. The property is situated on Block 9, Lots 1-6. With the recent decrease in the water table Mr. Kangas has concern there will not be water available if homes were to be developed on the lots. The Board will visit with Dave Shaw with ERO Engineering and be in contact with Mr. Kangas.

At 11:00 a.m. Joe Langan with Idaho Department of Juvenile Corrections and Owyhee County Juvenile Probation Supervisor Ivy Cardenas met with the Board to present the 2019 Annual Report. A statewide and national trend has carried over to Owyhee County with a decline in juvenile arrests, petitions, misdemeanors and felony offenses. No action was taken.

At 12:24 p.m. Commissioner Hoagland asked for a motion to amend the agenda due to time issues for an item not currently on the agenda. Commissioner Merrick made a motion to amend the agenda to include appointing a hearing examiner for a hearing to be held on Monday February 24, 2020. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Merrick made a motion to appoint Jim Desmond as the hearing examiner for the Trinity Rock Subdivision hearing scheduled for Monday February 24, 2020 at 10:00 a.m. Motion was seconded by Commissioner Aberasturi and carried.

The Boise District BLM Coordination Meeting was postponed until March 16, 2020.
