February 3, 2020

Present during the meeting were Commissioners Aberasturi, Merrick and Hoagland, Deputy Clerk Russell, Treasurer Dygert, Assessor Gruenwald, Planning and Zoning Director Huff, Sheriff Grant, Chief Deputy Sheriff Bowman, Sheriff Deputy Hoagland, Victim Witness Coordinator Studor, Civil Clerk White, Dispatcher Madsen, Jail Commander Vincent and Indigent and Charity Clerk Evans.

Commissioner Merrick made a motion to approve Indigent & Charity case 20-04. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Merrick made a motion to deny Indigent & Charity case 20-01 per Idaho Code 31-3511 – Applicant failed to cooperate with the county. Seconded by Commissioner Aberasturi. Motion carried.

At 11:00 a.m. the Board attended a site visit to the VanEs Dairy and adjoining county property.
