<b>Precinct</b>	<p>Shall the Board of Trustees of Glenns Ferry Joint School District #192, Elmore and Owyhee Counties, Idaho, be authorized and empowered to levy a supplemental levy, as permitted by law in Section 33-802(3), Idaho Code in the amount of \$350,000 (Three Hundred Fifty Thousand Dollars) each year for a period of (2) years for a total of \$700,000 (Seven Hundred Thousand Dollars) commencing with the fiscal year beginning July 1, 2018 and ending June 30, 2020 for the purpose of paying all lawful expenses of operating the schools of the district as provided in the resolution of the Board of Trustees of Glenns Ferry Joint School District #192 adopted on January 10, 2018.</p>	<p>Shall the Board of Trustees of Castleford Joint School District #417 be authorized to levy a Supplemental Levy in the amount of \$350,000 (Three Hundred Fifty Thousand) per year for a period of (2) years commencing with the fiscal year beginning July 1, 2018, for the purpose of paying all lawful expenses of maintaining and operating the District as provided in the resolution of the Board of Trustees of Castleford Joint School District #417, adopted on January 17, 2018.</p>
