March 23, 2020

Present during the meeting were Commissioners Merrick, Aberasturi and Hoagland, Clerk Barkell, Deputy Clerk Russell, Chief Deputy Treasurer McGrew, Chief Deputy Assessor Prohl, Sheriff Grant, Jail Commander Vincent, Indigent and Charity Clerk Evans, via teleconference – 911 Supervisor Kipper, Natural Resources Director Desmond, Treasurer Dygert, Todd Kleppinger with the Owyhee Avalanche and Rangeland Consultant Chad Gibson and Boise District BLM representatives for the BLM Coordination Meeting.

Commissioner Merrick made a motion to set the agenda as presented. Motion was seconded by Commissioner Aberasturi and carried.

Commissioner Merrick made a motion to approve the minutes from the March 16, 2020 meeting. Motion was seconded by Commissioner Aberasturi. Motion was carried.

Commissioner Merrick made a motion to approve the minutes from the March 20, 2020 special meeting. Motion was seconded by Commissioner Aberasturi. Motion was carried.

Motion was seconded by Commissioner Aberasturi. Motion was carried.

Commissioner Aberasturi made a motion to approve the Sheriff's Dispatch hire of Julie Morgan, to begin March 25, 2020 at a grade 7 and \$15.50 per hour. Seconded by Commissioner Merrick. Motion carried.

Commissioner Merrick made a motion to approve the Infectious Disease Policy for Owyhee County after a short discussion regarding the Emergency Family and Medical Leave Act Policy. Commissioner Aberasturi seconded the motion. Motion was carried.


Commissioner Merrick made a motion to place a lien on Indigent and Charity case 20-09 and 20-10. Motion was seconded by Commissioner Aberasturi. Motion was carried.

Commissioner Merrick made a motion to deny Indigent and Charity case 20-08 per Idaho Code 31-3511 – Applicant failed to cooperate with the County. Motion was seconded by Commissioner Aberasturi and carried.
