In old business, the Board will proceed with the purchase of county owned property by Desert Real Estate LLC once consulting with the Prosecuting Attorney.

Also, in old business, Commissioner Aberasturi made a motion to approve the Sawtooth Correctional Medicine Contract for the jail. Motion was seconded and carried by Commissioner Merrick.

Commissioner Aberasturi made a motion to set the agenda as presented. Commissioner Merrick seconded the motion and it carried.

Commissioner Aberasturi made a motion to approve the minutes from the September 28, 2020 meeting. Motion was seconded and carried by Commissioner Merrick.

Commissioner Aberasturi made a motion to approve the Idaho Office of Emergency Management Subrecipient Agreement Duns 144521981 in the amount of \$15,665.55 with a match of \$15,665.55 (100% match). Motion was seconded and carried by Commissioner Merrick.

Commissioner Aberasturi made a to approve the Idaho Department of Juvenile Correction SUDS / CBAS Program Memorandum of Agreement for the Owyhee County Probation Department. Motion was seconded by Commissioner Merrick and carried.

The Alternative Analysis Memorandum for the North Fork Boulder Creek Bridge was tabled.

Commissioner Aberasturi made a motion to approve the pay increase for Robin Monahan from \$14.50 per hour as Roll Clerk / Deed Processor, to \$14.76 per hour as Appraiser. Motion was seconded and carried by Commissioner Merrick.

Commissioner Merrick made a motion to place a lien on Indigent and Charity case 20-22. Motion was seconded and carried by Commissioner Aberasturi.

Commissioner Merrick made a motion to deny Indigent and Charity case 20-19, Idaho Code 31-3511, applicant failed to cooperate with the County. Motion was seconded by Commissioner Aberasturi and carried.

At 10:00 a.m., a tax deed sale for parcel RPB0380006003A was held. 2 bidders were present. Minimum bid was \$8,271.76. Bidder #1 opened the bidding at #8,272.76. Final bid of \$10,000.00 by bidder #1 was accepted and the property sold.

At 10:30 a.m. the RV Ordinance public meeting was held.
