Commissioner Merrick made a motion to approve a letter to US Fish and Wildlife Service regarding the Lepidium Critical Habitat Proposal. Motion was seconded by Commissioner Aberasturi and carried.

Commissioner Aberasturi made a motion to approve a contract with Jim Desmond as Owyhee County Natural Resources Director, County Staff Coordinator, County Emergency Services Coordinator, and in the nature of other services specified. Motion was seconded by Commissioner Merrick and carried.

Commissioner Merrick made a motion to deny Indigent and Charity case 20-17. Motion was seconded and carried by Commissioner Aberasturi.

Commissioner Merrick made a motion to deny Indigent and Charity case 20-18. Motion was seconded and carried by Commissioner Aberasturi.

At 10:00 a.m. a public hearing was held to open the 2020 Budget. No public was present. Commissioner Aberasturi made a motion to approve Resolution 2020-28: To Open the 2020 Fiscal Year Budget to account for unanticipated revenues and expenses for a Cell Phone Optimization Project Grant. Motion was seconded and carried by Commissioner Merrick.

At 10:12 a.m. Commissioner Merrick made a motion to go into executive session pursuant to Idaho Code 74-206 (a), (b) & (f) communicate with legal counsel regarding personnel issues and possible litigation. Commissioner Aberasturi seconded the motion. Merrick – aye, Aberasturi – aye, Hoagland - aye. Motion was unanimous. No action was taken. Open session was resumed at 10:28 a.m.
