Commissioner Aberasturi made a motion to approve the Application for Payment from Thueson Construction for the parking lot paving project in the amount of \$134,136.49. Motion was seconded by Commissioner Merrick and carried.

Commissioner Merrick made a motion to approve the Assessors Request for Road Name of Chase Lane. Motion was seconded by Commissioner Aberasturi and carried.

Commissioner Aberasturi made a motion to rescind as Region IV Broadband Grant Administrator. Motion was seconded and carried by Commissioner Merrick.

The 2020 Defending Attorney Annual Report for Robert Chastain was reviewed by the Board.

The Sheriffs Remote Access Issues was tabled.


The Sheriff's request to purchase radio repeaters with COVID Cares Act funds was tabled.
