### OWYHEE COUNTY RESOLUTION NO. 94-03

### RESOLUTION PROCLAIMING PUBLIC USE FOR RIGHTS-OF-WAY UPON AND ACROSS FEDERALLY MANAGED AND STATE MANAGED LANDS IN OWYHEE COUNTY

WHEREAS, by Owyhee County Ordinance 93-02, the Board of Owyhee County Commissioners has recognized that since initial settlement of Owyhee County Lands, owners of private land and of private property interests have necessarily asserted and used rights-of-way upon and across the federally managed and state managed lands lying within the county in order to obtain beneficial and economically efficient use of their private land and property interests; and

WHEREAS, such use of private land and property interests is vital to the commerce and economic stability of Owyhee County; and

WHEREAS, the official Owyhee County Land Use Planning Committee has through its efforts made it clear that such rights-of-way are not only essential to the commerce and economic stability of Owyhee County, but also to the continuation and preservation of the custom and culture of Owyhee County because of the necessity of such rights-of-way for sustaining traditional multiple range uses such as grazing and other agricultural uses, mining uses, recreational uses such as but not limited to off highway motorized vehicles, equestrians, hunting, fishing, sight seeing, and camping, wood gathering uses and uses for access to water; and

WHEREAS, by adoption of the Owyhee County Interim Land Use Management Plan the county has provided for continued multiple use of the federally managed lands within the county and continued sustained uses for all those uses identified in the Plan and the planning process; and

WHEREAS, by Owyhee County Ordinance 93-02 the Board of County Commissioners declared it to be in the best interests of the citizens of Owyhee County to promote and foster commerce and economic stability by authorizing the County Recorder to receive and record assertions of rights-of-way upon and across the federally managed and state managed lands lying within the county; and

WHEREAS, subsequent to passage of Ordinance No. 93-02 the Idaho State Legislature made effective Idaho Code §40-204A whereby the State of Idaho recognized that the act of construction and

first use constituted acceptance of the grant of rights-of-way over federally managed lands to the public and that upon such acceptance the grant by the United States Congress evidenced by Revised Statute 2477 became effective for a perpetual term; and

WHEREAS, the Idaho State Legislature also recognized by enacting 40-204A that the only method of abandonment of such rights-of-way is by eminent domain proceedings and that neither the passage of time nor the frequency of use shall be considered a basis for abandonment of such rights-of-way; and

WHEREAS, the Idaho State Legislature has also decreed in Section 40-204A that such rights-of-way may be documented by maps, affidavits, surveys, books and other historic information; and

WHEREAS, the Idaho State Legislature has also mandated that any political subdivision of the state, which includes Owyhee County, may proclaim user rights to the rights-of-way acknowledged by the provisions of Revised Statute 2477; and

WHEREAS, the Idaho State Legislature has in Idaho Code §40-107 defined such rights-of-way to mean:

"Rights-of-way on federal land within the context of Revised Statute 2477, codified as 43 United States Code 932, and other federal access grants and shall be considered to be any road, trail, access or way upon which construction has been carried out to the standard in which public rights-of-way were built within historic context. These rights-of-way may include, but not be limited to, horse paths, cattle trails, irrigation canals, water ways, ditches, pipelines or other means of water transmission and their attendant access for maintenance, wagon roads, jeep trails, logging roads, homestead roads, mine to market roads, and all other ways.";

and

WHEREAS, the Board of County Commissioners finds that it is in the best interests of all members of the public in Owyhee County that the public use of such rights-of-way as defined by the Idaho State Legislature and as acknowledged by Revised Statute 2477 be proclaimed by the Board in its capacity as elected representatives of all members of the public of Owyhee County; and

WHEREAS, the Board of County Commissioners has reviewed United States Department of Interior Geological Survey Maps No. 1 through 161, as presented by the Office of the Assessor of Owyhee County, Idaho Land and Status Maps compiled from U.S. State and County records and dated August, September and November, 1946, as

provided by the Office of the Assessor of Owyhee County and determined that such maps are sufficient to document such rights of way;

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Board of Owyhee County Commissioners proclaims user rights in behalf of the public to all rights-of-way as defined by the Idaho State Legislature in Idaho Code §40-107 and as historically recognized and acknowledged by Revised Statute 2477, and as shown on United States Department of Interior Geological Survey Maps No. 1 through 161 as attached to this Resolution, and by Idaho Land and Status Maps compiled from U.S. State and County records, and dated August, September and November, 1946 as attached to this Resolution, to the full extent of their existence, historically;

IT IS HEREBY FURTHER RESOLVED by the Board of Owyhee County Commissioners that the Chairman of said Board be authorized and directed to execute an assertion of right-of-way form as provided by the Owyhee County Recorder and to file said form asserting rights-of-way in conformance with this Resolution with said Owyhee County Recorder.
