February 8, 2021

Commissioner Hoagland made a motion to set the agenda. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve the 2-1-21 minutes. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve Resolution 2021-04 - Transfer of a Service Weapon to a Retiring Employee regarding Deputy McGrew and his retirement from duty on January 31, 2021. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the tax cancellation on Parcel No RP03N04W294641 in the amount of \$351.83. The homeowner received tax exemption for 2020, which was inadvertently left off when property taxes were calculated. Motion was seconded by Commissioner Hoagland. Motion carried. There being no further business the meeting was adjourned.

Commissioner Aberasturi made a motion to approve the CDC COVID-19 Guidelines re Owyhee County Employee Policy. This policy states that the Owyhee County Employee Policy will follow CDC guidelines as they continue to be updated regarding COVID-19 guidelines and information. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve Certificate of Residency number 21-04 for College of Western Idaho. Motion was seconded by Commissioner Hoagland. Motion carried.
