Commissioner Hoagland made a motion to approve the M2 Automation quote of \$662.00 for a Lockdown Button for the Owyhee County Courthouse. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve postage machine lease agreement with Pitney Bows for \$1,055.10 to be paid quarterly with a tentative effective date of May 10, 2021. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion approve Certificate of Residence 21-06 for College of Western Idaho. Motion was seconded by Commissioner Hoagland. Motion carried.

Aberasturi – aye, Hoagland – aye, Merrick - aye. Motion was unanimous. No action was taken. Open session was resumed at 10:04 a.m.

Discussion – Ms. Forster presented to the Board a few concerns regarding her neighbor's property on Trap Shoot Road in Marsing. Her concerns include: 1) house hold trash and solid waste build-up around the property bringing scavenger animals to the neighborhood; 2) the use of the property as a dog sanctuary; and 3) the breeding of 'wolf pups' and the unkenneled 'wolf' breeding pair.

- West Wide Energy Corridor
 - o Commissioners requested Congressman Fulcher push to have this removed from the Washington D.C. agenda all together.

- Dam breaching
 - o Commissioners requested Congressman Fulcher push to have this removed from the Washington D.C. agenda all together.
- Off-road and 4-wheel drive vehicle traffic in Owyhee County
 - O Commissioners requested assistance with funds allocation from the Federal government for County road maintenance pertaining to the increased and now heavy use of County dirt and gravel roads; and law enforcement patrols pertaining directly to the increase in vehicles and people utilizing County and private property to get to BLM land for off-road and 4-wheel drive vehicles.

There being no further business the meeting was adjourned.
