Commissioner Hoagland made a motion to set the agenda as presented. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve and pay all outstanding bills for the departments listed below. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve the 04-12-2021 minutes. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve the transfer of Brandi Long from part time DMV to Deputy Treasurer in Murphy at the pay rate of \$13.50 an hour. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the 2022 Liquor Licenses for the five (5) businesses listed below. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the Computer Arts Barracuda System Backup five (5) year contract with three (3) annual payments of \$11,819.63 for a total of \$35,458.89. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the CXT quote for a Cheyenne bathroom and shower combination at the Homedale Fairgrounds at \$231,400 with a monthly payment of \$4,651.14 for five (5) years. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the M2 Automation quote for Jail Controls Air Compressor Replacement at \$8,946 pending approval for use of 2020 Homeland Security Grant funds for approximately half of the cost. Motion was seconded by Commissioner Hoagland. Motion carried. Commissioner Aberasturi made a motion to approve the use of 2020 Homeland Security Grant funds to purchase Radios for the Sheriff's Office. Motion was seconded by Commissioner Hoagland. Motion carried.


Commissioner Hoagland made a motion to approve I&C case 19-03. Motion was seconded by Commissioner Aberasturi. Motion carried.
