May 10, 2021

Present during the meeting were Commissioner Hoagland, Commissioner Merrick, Commissioner Aberasturi, Clerk Barkell, Deputy Clerk Yoshikane, Assessor Gruenwald, Deputy Treasurer Stoumbaugh, Sheriff Grant, Prosecutor Phillips, and Natural Resources Director Desmond. Commissioner Hoagland made a motion to set the agenda as presented. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve the May 3, 2021 minutes. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve the re-hire of Terry McGrew for the part time position of Idaho Power Deputy and Waterways with the Sheriff's Department, to begin on May 10, 2021, at the pay rate of \$20.93 an hour. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve Indigent Defense Financial Assistance Compliance Proposal Application FY 2022. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve the renewal of Alcoholic Beverage Licenses #13 –Y Bar & Café and #14 – Rebecca's Market & Restaurant. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve a letter regarding the road maintenance contract between Owyhee County and Mt. Home Air Force Base. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve the re-zoning of Fuquay and Gruenwald properties south of Murphy. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve Certificates of Residency 21-09 & 21-10 for College of Western Idaho and Certificates of Residency 21-01 & 21-02 for College of Southern Idaho. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve I&C case 21-10. Motion was seconded by Commissioner Aberasturi. Motion carried.

At 9:51 a.m. Commissioner Hoagland made a motion to go into executive session pursuant to Idaho Code 74-206 (c) acquisition of an interest in real property. Motion was seconded by Commissioner Aberasturi. Aberasturi – aye, Hoagland – aye, Merrick - aye. Motion was unanimous. No action was taken. Open session was resumed at 10:03 a.m.
