Commissioner Hoagland made a motion to approve the Attorney-Client Engagement Agreement for FY 2021-22 with Maren Ericson. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve the Sawtooth Correctional Medicine 2021-22 Medical Services Contract with Eric Wells for \$2,750 per month. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the MOU between Owyhee County, Eastern Owyhee Cooperative Weed Management Area, Bruneau River Soil and Water Conservation District, and Shoshone-Paiute Tribe with the Chairman's signature for the Board. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the Paragon Consulting Agreement for the Provision of Limited Professional Services for the Reynolds Creek Rd Rehab Project. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a potion to approve the Paragon Consulting, Inc 2021-ID-FLAP Application – update and completion for Bachman Grade Road for the amount of \$5,000. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the Prosecuting Attorney's new hire Corynne Patterson for the part-time position of Jr. Legal Secretary, at the pay rate of \$13.83 per hour to begin on October 7, 2021. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve I&C case #18-42. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to deny I&C case #21-14, per Idaho Code 31-3502(17) - County is not the last resource. Motion was seconded by Commissioner Aberasturi. Motion carried.

Discussion – Rocky Widner and Terry Jensen discussed with the Board with their concerns regarding rain water run-off from Bates Creek Road on their separate properties. Both parties stated they have run-off water damage to properties several times within the past two (2) years and would like to see the road better and more appropriately maintained to prevent, or at least mitigate, the water damage. Rocky and Terry also voiced their concerns regarding OHV traffic on Bates Creek Road by their properties. Each stating that the lack of speed limit and road closed to OHV use is unacceptable and gives them and the other property owners zero back-up when they approach the OHV drivers. Commissioner Hoagland stated that he would speak with the Road & Bridge 1 Supervisor Rittenhouse about visiting the concerning sections of Bates Creek Road to figure out what can be done to at least mitigate the rain water run-off.

There being no further business the meeting was adjourned.
