December 13, 2021

Present during the meeting were Commissioner Hoagland, Commissioner Merrick, Commissioner Aberasturi, Clerk Barkell, Chief Deputy Clerk Yoshikane, Assessor Monahan, Treasurer Dygert, , Prosecutor Phillips, Chief Deputy Sheriff Bowman. Via Zoom – Natural Resources Director Desmond.

Commissioner Hoagland made a motion to set the agenda with the amendment to add Resolution 2021-22 – Closure of Silver City Road and Bachman Grade Road due to hazardous winter conditions. Motion was seconded by Commissioner Aberasturi and carried.

Commissioner Hoagland made a motion to approve the 12-06-2021 minutes. Motion was seconded by Commissioner Aberasturi and carried.

Commissioner Hoagland made a motion to approve the Dist. 3 FY2022 Aggregate Crushing Task Order with Paragon Consulting for \$10,000 with the Chairman's signature for the Board. Motion was seconded by Commissioner Aberasturi and carried.

Commissioner Aberasturi made a motion to approve the Extension Office's pay increase for 4-H Program Coordinator Madison Anderson from \$14.00 per hour to \$14.30 per hour beginning on December 20, 2021. Motion was seconded by Commissioner Hoagland and carried.

Commissioner Hoagland made a motion to approve the FLAP Joint Endorsement with Paragon Consulting for the Bachman Grade Road Rehab Project. Motion was seconded by Commissioner Aberasturi and carried.

Commissioner Aberasturi made a motion to approve the Indigent Defense Expenditure Report FY 2021 in the amount of \$236,924.00. Motion was seconded by Commissioner Hoagland and carried.

Commissioner Aberasturi made a motion to approve the Jet Ski title transfer as authorized by the BOCC with Resolution 2021-16 – Sheriff's Office to trade one jet ski and use the proceeds as credit towards the purchase of two watercraft. Motion was seconded by Commissioner Hoagland and carried.

Commissioner Aberasturi made a motion to approve Resolution 2021-21 – Opioid Settlement with McKesson Corp, Cardinal Health, Inc., AmerisourceBergen Corp, J&J, Jansen Pharm., Inc., Ortho-McNeil Janssen Pharm., and Janssen Pharm. Motion was seconded by Commissioner Hoagland and carried.

Commissioner Aberasturi made a motion to approve the Sheriff's new hire of Paul Maund for a part time Detention Deputy position at the pay rate of \$18.08 per hour to begin on December 14, 2021. Motion was seconded by Commissioner Hoagland and carried.

Commissioner Aberasturi made a motion to approve the Sheriff's rehire of Perry McCormack for a temporary Sheriff Deputy position at the pay rate of \$19.53 per hour to begin on December 20, 2021. Motion was seconded by Commissioner Hoagland and carried.

Commissioner Aberasturi made a motion to approve the Sheriff's transfer of Miguel Ruiz from Detention Deputy to Patrol Deputy; moving from the pay rate of \$17.22 to \$18.08 per hour and to begin on December 13, 2021. Motion was seconded by Commissioner Hoagland and carried.

Commissioner Hoagland made a motion to approve Resolution 2021-22 – Close Silver City Rd and Bachman Grade Rd due to hazardous winter weather conditions. Motion was seconded by Commissioner Aberasturi and carried.


Commissioner Hoagland made a motion to approve the denial of I&C case number 21-17. Motion was seconded by Commissioner Aberasturi and carried.
