Present during the meeting were Commissioners Hoagland, Aberasturi, and Merrick, Clerk Barkell, Human Resources Administrator Fahey, Assessor Monahan, Chief Deputy Treasurer Stoumbaugh, Prosecuting Attorney Phillips, Natural Resources Director Desmond, Sheriff Grant, Chief Bowman, Citizens Theresa Phifer and Karen Steenhoff. Present via zoom – Civil Clerk White, Treasurer Dygert and P&Z Planner Nettleton.

Commissioner Hoagland made motion to set the agenda as presented. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve the minutes from the March 21, 2022 meeting. Motion was seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to the Fair Housing Proclamation, declaring April 2022 as Fair Housing Month in Owyhee County. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve sending an amendment request to the Bureau of Land Management for the right of way at Black Sands Resort in order to install a vault style toilet. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the Imagine Idaho Privacy Agreement for the use of the crowd sourcing software. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the Imagine Idaho Crowdsourcing Software Agreement. Motion was seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve the 2022 Reynold Creek Road Paving Project with Idaho Materials & Construction in the amount of \$620,145.00. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve the approve the Sheriff's office rehire of Greg Bishop. Matter was tabled.

At 9:30 a.m. Commissioner Hoagland made a motion to go into executive session pursuant to Idaho Code 74-206 (f) possible litigation and Idaho Code 74-206 (a) personnel. Commissioner Aberasturi seconded the motion. Merrick-aye, Aberasturi-aye Hoagland-aye. Motion was unanimous. No action was taken. Open session was resumed at 10:02 a.m.


Citizen Theresa Phifer asked the Board what she can do or if they can do anything about a neighbor that is digging close to her property line, which she believes to be a gravel pit. The Board instructed her to contact Planning and Zoning and they can inquire with the property owner regarding the need for a conditional use permit if they are operating a commercial business.

Commissioner Aberasturi made a motion to approved the re-hire of Greg Bishop as a Sheriff's Patrol Lieutenant at \$25.00 as a seasonal employee. One aye vote was recorded and two nah votes were recorded. Motion failed.

A coordination meeting with the Boise District BLM was held.


There being no further business, the meeting was adjourned.
