Old Business – Commissioner Aberasturi made a motion to approve the HazMat grant award for Homedale Fire Department in the amount of \$14,817.99 for SCBA air packs, generator and two hazardous waste kits. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the HazMat grand award for Marsing Ambulance in the amount of \$15,182.01 for the purchase of a Zoll X series monitor/defibrillator. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the Sparklight Contract for internet services to the Owyhee County Fairgrounds at \$141.48 per month. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the re-hire of Paul Rhoades as a part-time dispatcher at the rate of \$19.13 per hour. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the promotion of Tearsy Freeman to Dispatch Supervisor at the rate of \$21.26 per hour. Motion seconded by Commissioner Hoagland. Motion carried.

Kirby Cook from Civil Dynamics gave the Board a brief update on the Murphy Sewer project. Commissioner Aberasturi commented that if we have to wait longer to start the project he would like to incorporate the Murphy Water project at the same time so they will only need to tear up the street one time.

Commissioner Aberasturi made a motion to approve an Application for Drilling Permit to the State of Idaho, Department of Water Resources for a well at the Homedale Fairgrounds, with signature of the Chairman. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the Notice to Proceed for Riverside Inc to start the well drilling project at the Homedale Fairgrounds, with the signature of the Chairman. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve a contract with Riverside Inc to drill a well at the Homedale Fairgrounds in the amount of \$88,565.00, with the signature of the Chairman. Seconded by Commissioner Hoagland. Motion carried.


