Commissioner Aberasturi motioned to approve the Civil Science Change Order #2 for the North Fork Boulder Creek Bridge Project, with a decrease in the amount of \$4,500.00, for a new total in the amount of \$23,490.00. Seconded by Commissioner Bachman. Motion carried.

Commissioner Aberasturi motioned to approve the Idaho GeoComm GIS Services Contract for the Sheriff's Office in the amount of \$37,873.00, with the Chairman's signature for the Board. Seconded by Commissioner Bachman. Motion carried.

Commissioner Aberasturi motioned to approve the Medical Services FY2024 Contract between Sawtooth Correctional Medicine with Eric Wells and the Sheriff's Office in the amount of \$35,220.00 per year or \$2,935 per month. Seconded by Commissioner Bachman. Motion carried.

Commissioner Aberasturi motioned to approve the Succor Creek Construction Pay Application #1 for architecture work done on the Owyhee County Justice Center located in Homedale, Idaho in the amount of \$85,821.90. Seconded by Commissioner Bachman. Motion carried.

Commissioner Bachman motioned to approve the Twin Falls Highway District Fiscal years 2024, 2025, & 2026 Road Maintenance Agreement with an annual payment of \$1,500 (County budget allowing). Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi motioned to approve the University of Idaho FY2024 memorandum of understanding with all three Commissioner signatures on page five (5) and the signature of the Chairman on page seven (7). Seconded by Commissioner Bachman. Motion carried.

Commissioner Aberasturi motioned to approve the certificates of residency 2023-08 & 2023-09 for College of Southern Idaho and certificate of residency 2023-20 for College of Western Idaho. Seconded by Commissioner Bachman. Motion carried.

At 9:43 a.m. Commissioner Aberasturi made a motion to go into executive session pursuant to Idaho Code §74-206 (c) interest in real property. Commissioner Bachman seconded the motion. Hoagland – aye, Aberasturi – aye, Bachman- aye. Motion was carried. Open session was resumed at 9:51 a.m. No action was taken.

Commissioner Bachman's motion died to table County Resolution 2023-37 due to possible confusion regarding whether this was a public hearing or not.

Commissioner Aberasturi motioned to approve County Resolution 2023-37: Road Name Update - Pleasant Valley Rd / Trout Creek Rd - Yturri Rd / Will Become Trout Creek Road. Seconded by Commissioner Bachman. Motion carried.


Clearwater Financial – Tabled until October 16, 2023


There being no further business the meeting was adjourned.
