Commissioner Bachman motioned to approve the Owyhee County Fair Board re Letter of Resignation from Jake Astorquia. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi motioned to approve 2025 Liquor License Renewal No. 1 for Golden Ocean Chinese Restaurant in Homedale. Seconded by Commissioner Bachman. Motion carried.

Reviewed department quarterly reports and performed quarterly jail inspection.

Met with Jarbidge District BLM for monthly coordination meeting.

COUNTY RV ORDINANCE continued – Commissioner Bachman made clear that she knows an RV ordinance is needed in Owyhee County and absolutely wants to continue moving forward; PA Topmiller confirmed that the current County Code relating to the living in RVs can be amended. Commissioner Bachman encouraged the public to participate in this process. Commissioner Aberasturi made clear that law enforcement has to be a part of the amendments as it is no longer safe for the Commissioners and/or Planning & Zoning to approach the illegal and unsafe RV dwellings. P&Z Director Huff reiterated her request for a Code Enforcement Officer and spoke on the reason for the permit fees and stated that there are several ways to go about making sure that the County's tax base (property owners) are not subsidizing wages for working being done for items that should largely be funded by permit fees. PA Topmiller went over amendment options to know how the Board would like to proceed. Moving forward, discussions between the Board and County residents will be part of the amendment process, making sure that a balance between the need for safety and rights for private land owners can be reached. And provisions for a code enforcement officer that are already in place for the County will be looked into for how to incorporate into the current RV ordinance amendments.

There being no further business the meeting was adjourned.
