**OHV Committee** – Idaho Code 67-7126(a) Sheriffs of counties with a current or an actively developing off-highway vehicle law enforcement program recognized by the department shall receive moneys from the fund based upon a formula as provided in rule promulgated by the board; and (b) Moneys from the fund shall be used only for off-highway-related law enforcement activities;
