The Owyhee County Fair Board invites you to participate in this year's fair, August 5th to the 10th 2024. This is an agreement or contract, for a food booth at the 2024 fair. It must be returned to the fair office by June 30, 2024 to guarantee a space. The rental charge will be \$500.00, with the money being submitted at the time you reserve the space. Please be courteous of the space that you are given.

1. Agreement made between Owyhee County, a political subdivision of the state of Idaho, herein County and _____
2. User intends to Sell the following:

3. User will Agree to keep the booth clean and attractive at all times and when leave see that it is in good clean condition.
4. User agrees to obtain a comprehensive damage and bodily injury of liability insurance policy from an insurance company licensed to do business in the state of Idaho on the booth space for the term of this rental with the county named as an additional insured and for a minimum of \$1,000,000.00
5. By signing this agreement, user to indemnify and hold harmless County from liability for any injury or damage.
6. User will comply to all local laws, and rules and regulations of the county and state.
7. User will only sell the food that is on the list of food to be sold that is approved by the board.
8. The county has the right to impose additional regulations on the use of the food booths or grounds for the purpose of the health and safety of the fair visitors and exhibitors.
9. No knives, weapons or fireworks. No DOGS!!!!
10. User agrees to be responsible for the disposal of all the grease buckets. Failure to do this will result in a \$200.00 fine and you could loss the right to come in the future.
11. User will need the fair board's approval before making any and all improvements to the food booth.
12. User will not sub lease the booth.

13. All items sold in the booth must be on the application/contract. Items not listed on the contract may not be sold. The fair board does not guarantee exclusivity of the food items but it is their general policy to provide a variety of items to the food goers. Only approved items will be sold.
14. User agrees that **NO VEHICLES WILL BE DRIVEN ON THE FAIRGROUNDS AFTER 5PM EACH DAY. VEHICLES WILL NOT BE PARKED NEAR OR AROUND THE FOOD BOOTH ANYTIME DURING THE FAIR. VEHICLES WILL ONLY DRIVE ON THE GROUNDS TO UNLOAD AND LOAD NECESSARY ITEMS. THIS MUST BE DONE BEFORE 5PM**

We agree to the above conditions and will operate by them.
