Waterways Update with Sgt. McCormack – spoke on the Idaho Power Waterways contract and the need to have deputies cross deputized between Owyhee and Elmore Counties; spoke about the next steps for the Idaho Boating Safety grant draft report he presented to the Board last week.

Commissioner Bachman motioned to appoint retired Sgt. McCormack to act as liaison between the County and interested parties regarding matters pertaining to the Idaho Boating Safety Act 1986-2024. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Bachman shared information from last week's joint meeting with The Bureau of Land Management, Idaho State Department of Agriculture, and Animal & Plant Health Inspection Service regarding the 2024 Mormon Cricket and Grasshopper issue.

County Project Updates – Engineer Cook shared that the fairgrounds well house building was being set that day and that sod & gravel would be completed by the end of the week. Facility plans for the courthouse lagoons are almost ready, the survey TOPO will be completed in the coming week; hoping to have approved plans in place by late summer / early fall so the project can go out to bid and work can begin before winter starts. Murphy water project is in the public outreach stage and grants are being searched for.

At 11:45 a.m. the Board canvassed the votes of the May 21, 2024 Primary Election.
