Resolution Setting Various Fees of Owyhee County

WHEREAS, Idaho Code 31-870, Powers and Duties of Board of Commissioners, permits the Board of County Commissioners of each county to set fees by resolution; and

WHEREAS, such fees shall be in an amount reasonably related to, but not exceeding, the actual costs of such services; and

WHEREAS, the various county offices have reviewed and analyzed the actual cost of providing services and determined that new fees are needed and certain existing fees should be increased to more accurately reflect, but not exceed, the actual costs of providing the services, as provided in Idaho Code 31-870 (1) and 31-870 (4); and

WHEREAS, the following table of fees is needed to cover, but not exceed costs, including wages, benefits, technology, supplies, equipment, fuel, vehicle maintenance and/or infrastructure costs associated with the listed fees; and

WHEREAS, in accordance with Idaho Code 63-1311A, the Owyhee County Board of Commissioners held a public hearing on September 22, 2025 to take public comment on the proposed fees, with said hearing having been properly advertised in the county newspaper the two weeks preceding the hearing.

THEREFORE, BE IT RESOLVED that following fees be increased as shown in the table below to reflect the actual costs of providing these services.
