

OWYHEE COUNTY RESOLUTION NO. 2025-50

Resolution to close portions of Bachman Grade Road, Cow Creek Road, Flint Creek Road, Jordan Creek Road, Juniper Mountain Road, Mud Flat Road and Silver City Road for automobile travel, effective immediately due to icy, snow, and weather conditions, until further action of the Board of County Commissioners.

WHEREAS, Idaho Code §31-801 grants the Owyhee County Board of Commissioners in their respective counties all jurisdiction and authority within the legal confines of their statutory office; and

WHEREAS, pursuant to Idaho Code §31-805, the Owyhee County Board of Commissioners have granted authority to control and manage public roads and bridges within the county; and

WHEREAS, Idaho Code §31-828 grants to the Board of County Commissioners authority to do and perform all other acts which may be necessary to discharge the duties if the executive authority of county government; and

WHEREAS, the road conditions on portions of **Bachman Grade, Cow Creek, Flint Creek, Jordan Creek, Juniper Mountain, Mud Flat and Silver City as described in Exhibit A** due to ice, snow and weather conditions have become hazardous and/or otherwise impassable by automobile travel. Such roads are not maintained during the winter months; and

WHEREAS, the specific roads to be temporarily closed are more particularly described in **Exhibit A**, attached hereto and incorporated herein by reference;

WHEREAS, IT IS THEREFORE RESOLVED and known that the Owyhee County Board of Commissioners do hereby declare that portions of **Bachman Grade Road, Cow Creek Road, Flint Creek Road, Jordan Creek Road, Juniper Mountain Road, Mudflat Road and Silver City Road** to be closed to automobile travel until further action of the Board.

IT IS FURTHER RESOLVED THAT this Resolution is effective on the date of signatures of the Board.

EXHIBIT A
TEMPORARY ROAD CLOSURES

Bachman Grade Road - starting at 24018 Bachman Grade Road.

Cow Creek Road – Starting at the southern point as marked by the BLM gravel pit in Section 17, 4 South, 5 West to Trout Creek Road.

Flint Creek Road – Starting at the eastern point as marked by the situs address of 13788 Flint Creek Road.

Jordan Creek Road – Starting at Jordan Creek road to Trout Creek Road.

Juniper Mountain Road – Starting at the southern point as marked by the situs address of 41691 Juniper Mountain Road.

Mud Flat Road – Starting at Perjue Canyon Rec Site to Juniper Mountain Road.

Silver City Road – Starting at Diamond Creek Mill to Jordan Creek Road.
